- Stat Service is \$160 per animal
- FAVN test is \$90 per animal
- Courier Service options- regardless of how many samples submitted:
  - International/US Domestic Priority = \$50
  - US Domestic 2<sup>nd</sup> Day = \$20

**Turnaround Time with a STAT:** A FAVN test that is a STAT is reported in 2 weeks or less. Please note that a STAT request does not guarantee a specific turnaround time; however it does ensure that the laboratory will give priority to the sample in testing, reading and reporting results.

## Instructions:

1. Please complete the Credit Card Authorization Form, indicating the total STAT fee(s). Cost of test(s) may be included as well. In the field for “Description of Charges”, record what your payment covers.
2. If you require the official FAVN report (stickered) for travel, we recommend you request courier service offered on the Credit Card Authorization Form. (If you submit through a referral lab, have them fax permission to send the report directly to you.) US Domestic results are sent by FedEx Express Saver if a courier service is not selected (excluding PO Box Addresses and failed results). International results are sent by US Postal Service Air Mail if a courier service is not selected.  
**Note:** Courier delivery is not needed for some destinations such as Hawaii, Guam and islands in the Caribbean. The Rabies Lab sends the official FAVN report directly to these locations after the test is completed.
3. Securely attach all necessary forms to FAVN REPORT FORM and submit with sample(s).
4. If requested in writing we can fax/email results directly to the submitting clinic and/or a government authority, such as a USDA office or quarantine station at no extra charge.
5. If concrete travel plans have been made, please include date by when results are needed to allow the laboratory to contact the submitting clinic in case we cannot meet your deadline.

The FAVN report is sent to the submitting clinic regardless of who pays for the test and shipping. However, the FAVN report can be sent to an alternate location if written and signed permission from the submitting clinic is provided.
